- a. FRP has a new website located at www.rehabpsych.net. Crosslinks have been re-established between Div22 and the new website; FRP content on Div22.org will be removed from the server shortly.
- b. Paul requested that Committee chairs check the Div 22 website for accuracy on their committee webpages and provide updates to membership and future leaders.
- c. Paul and Kim Monden are working on creating a Division 22 Archive for use by all committees to provide continuity and a historical reference for future use.

- c. Diversity Committee (Anthea Gray) – The Call to Action has been posted to the website. Specific action steps have been added to Section 2 of the Call to Actions, which should be implemented by the Division.
- d. Advocacy Committee (Sam Stern) – A response to the Executive Order to combat racism and sexist stereotyping has been sent out to the listserv and will be posted to the website. Website updates will be forthcoming.
